

# TEXAS 2100

## **Article I Name and Organization**

The name of this association is TEXAS 2100 and will be designated an unincorporated nonprofit association created under the laws of the State of Texas.

## **Article II Intent and Purpose**

TEXAS 2100 consists of three or more members joined by mutual consent for the common, nonprofit purposes of:

- completing activities and programs necessary to promote Texas independence through a legitimate, legal process
- researching social and other factors influencing attitudes and beliefs of Texas citizens and those outside Texas toward Texas' desire and ability to achieve a political and socio-economic separation from the United States (the "Union") through non-military means
- educating people in, but not limited to, the following areas:
  - political and social views regarding Texas separatism
  - political and social actions of a legal nature toward achieving Texas sovereignty
  - working with TEXAS 2100 and similar organizations toward achieving the political and social separation from the U.S. in a legal and sustained manner
- creating a networks of people and organizations sharing TEXAS 2100's vision

TEXAS 2100 may engage in any and all other charitable activities permitted to an organization exempt from federal income tax under Section 501(c)(3) of the Code or corresponding future provisions of the federal tax law. To these ends, TEXAS 2100 may do and engage in any and all lawful activities that may be incidental or reasonably necessary to any of these purposes, and it shall have and may exercise all other powers and authority now or hereafter conferred upon unincorporated nonprofit corporations in the State of Texas.

## **Article III Office and Duration**

The office of TEXAS 2100 will be located at the address at which the Secretary-Treasurer has official residence; or at such place as TEXAS 2100 may from time to time determine, or as the business of TEXAS 2100 may require. The duration of TEXAS 2100 will be perpetual. The death, removal, or resignation of any member of TEXAS 2100 shall not result in the dissolution of TEXAS 2100.

## **Article IV Structure and Membership**

# TEXAS 2100

TEXAS 2100 consists of individuals and groups dedicated to the promotion and advancement of the Association's vision and activities. Membership is open, but not limited to, any person or organization desiring to:

- achieve Texas sovereignty using legal means
- assist target constituencies in gaining information and skills needed to foster a state-wide majority desire to achieve Texas independence
- promoting the mission and efforts of TEXAS 2100 in serving its membership
- Improving the general well-being of the community through education and services

TEXAS 2100 is a purely voluntary organization. Membership fees or annual dues range from free membership to paid personal and corporate memberships as outlined and amended in the By-Laws. TEXAS 2100 does not discriminate by race, color, sex, age, religious or political affiliation, handicap, national origin, sexual orientation, or any other personal factor.

## **Article V Association Leadership**

TEXAS 2100 will be governed by at least three (3) officers to be determined according to Association By-Laws. The name and total number of officer positions will be determined as the membership requires, changeable as circumstances dictate.

One person will be designated as TEXAS 2100's agent in this state, as needed, following state law requirements. Fifty-five percent of the then-existing members constitute a quorum of TEXAS 2100. Association officers will be chosen as specified in the By-Laws.

## **Article VI Accounting and Records**

The fiscal year of TEXAS 2100 will be January 1 through December 31 of each year. All minute books, correspondence, and other records of TEXAS 2100 will be preserved by the Officers. Records that have ceased to be of use for the conduct of the affairs of TEXAS 2100 may be turned over for preservation to a depository designated by it or discarded.

## **Article VII Dissolution**

In the event of the dissolution of TEXAS 2100, its property, funds, and other assets will be transferred to whatever organization or organizations operated exclusively for charitable, educational, and/or scientific purposes as TEXAS 2100 may determine, provided such organization or organizations qualify as tax-exempt under the Internal Revenue Code of the United States.
